**AN ORDINANCE AMENDING ORDINANCE PROHIBITING THE FEEDING OF
GEESE OR WILD BIRDS ON OR ABOUT SLUICE POND AND FLAX POND
IN THE CITY OF LYNN**

Be it ordained by the City Council of the City of Lynn and by the authority of the same as follows, to wit:-

SECTION 1:00 .

No person shall feed any wild geese and ducks or other, wildlife that may congregate or gather on or about Sluice Pond, Flax Pond, Buchanan Bridge and/or Goldfish Pond.

SECTION 2:00

Any person Who violates the provisions of this ordinance shall be subject to a fine of not more than One Hundred (\$100.00) Dollars for each offense.

SECTION 3:00

The Health Department shall be the enforcing authority for all purposes.

SECTION 4:00

All ordinances or parts of ordinances inconsistent herewith are hereby repealed:

SECTION 5:00

This ordinance shall take effect thirty-one (31) days after its final adoption as advertised.

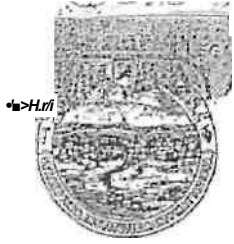
Be-it ordained by the City Council of the City of Lynn and by the authority of

Section 1 to read as follows:

SECTION 1. No person shall feed any wild geese and ducks or other wildlife that may
congregate or gather on or about Sluice Pond, Flax ; Pond or Goldfish Pond in the
City of Lynn.

SECTION 2. All ordinances or parts of ordinances inconsistent-herewith are hereby repealed.

SECTION 3. This ordinance shall take effect thirty-one (31) days after its final approval as
adopted and advertised.

other wildlife that, may congregate or gather on or about Sluice
Pond or Flax Pond.

SECTION 2. Any person who violates the provisions of this
ordinance shall be subject to a fine, of not more than, One Hundred
(\$100.00) Dollars for each offense.

SECTION.3. The Health Department shall be the enforcing
authority for all: purposes.

SECTION. 4. All ordinances or parts of ordinances inconsistent
■herewith are hereby repealed.

SECTION. 5. This ordinance shall take effect thirty-one (31) days
after its final adoption as advertised.
