AN ORDINANCE AMENDING THE ZONE ORDINANCE OF THE
CITY OF LYNN

Be it Ordained by the City Council of the City of Lynn
and by the authority of the same as follows to wit:-

SECTION 1. The Zone Ordinance of the City of Lynn, as
heretofore amended, is hereby further amended by adding
number 6 to Section 5 to read as follows J

"Health Clinics subject to the provisions of Section 18."

and by adding the words "Health Clinic" in Section 18 after
the- word "hospital" in paragraph "a"';.

by adding-in Section 13, Subsection e5, the following:

"Health Clinic" One space for each two staff members and
one space per examination room".

SECTION 2. A "Health Clinic" is a building or part of a
building used to administer physical or mental health
needs on an exclusively out-patient basis.

SECTION 3. All ordinances or parts of ordinances inconsistent
herewith are hereby repealed.

SECTION 4. This ordinance shall take effect upon its
adoption and approval, after advertising as adopted.

IN THE YEAR ONE THOUSAND NINE HUNDRED AND EIGHTY-FIVE AN ORDINANCE
ESTABLISHING THE HEALTH DEPARTMENT OF THE CITY OF LYNN

Be it Ordained by the City Council of the City of Lynn and by the authority
of the same as- follows, to wit:-

SECTION 1. There shall be in the City a department known as the Health Department which shall be under the charge of a Board of Health pursuant to the provisions of General Laws Chapter 111, Section 26. The Board of Health shall consist of three persons, one of whom shall be a physician. No one of them shall be a member of the City Council.

The members of the Board of Health shall be appointed by the Mayor, subject to confirmation by the City Council, for a term of three years. Said member may be removed by the Mayor, pursuant to terms of City Charter for cause. Vacancies shall be filled by appointment as aforesaid for the residue of the unexpired terms.

Members of the Board of Health shall receive such compensation as the City Council may determine.

Said board shall organize annually by the choice of one of its number as chairman. It may make rules and regulations for its own government and for the government of its officers, agents and assistants. It may appoint a clerk who shall not be a member of the board, and may employ the necessary officers, agents and assistants to execute the health laws and its regulations.

The salary or other compensation of its Executive Director, and other agents, assistants and employees shall be fixed by the Lynn City Council.

The mayor shall appoint an individual subject to confirmation of the City Council, who shall be the Executive Director of the Health Department. The Executive Director shall be the administrative officer of the Health Department and shall insure that the Day-to-day responsibilities and duties of the Health Department are successfully carried out. Said Executive Director may have such further duties as the Mayor, City Council or Board of Health may determine to be appropriate and necessary.

The Executive Director shall be appointed as aforesaid for a term of three years. He or she may be removed by the Mayor for cause notwithstanding pursuant to provisions of City Charter.

The salary of the Executive Director shall be \$25,986.00 effective January 1, 1985.
